

# Product End-of-Life Instructions

**Product Range: Masterpact NT (600 to 1600 A) with micrologic**

**Marketing Model/Name:**

**The End of Life Instruction (EOLI) covers the entire range:**

- **Masterpact NT 3-pole or 4-pole fixed or draw out circuit breaker / switch with a rating of 600 A to 1600 A**
- **fitted with a Micrologic A, P or H Control Unit and auxiliaries**
- **Manual or remote control.**

## **Purpose:**

The product family must be disposed according to the legislation of the country. This document is intended for use by end of life recyclers or treatment facilities. It provides the basic information to assure an appropriate end of life treatment for the components and materials of the product.

## **Note :**

This product family is in the scope of EU directive 2002/96/EC, Waste Electrical and Electronic Equipment (WEEE).

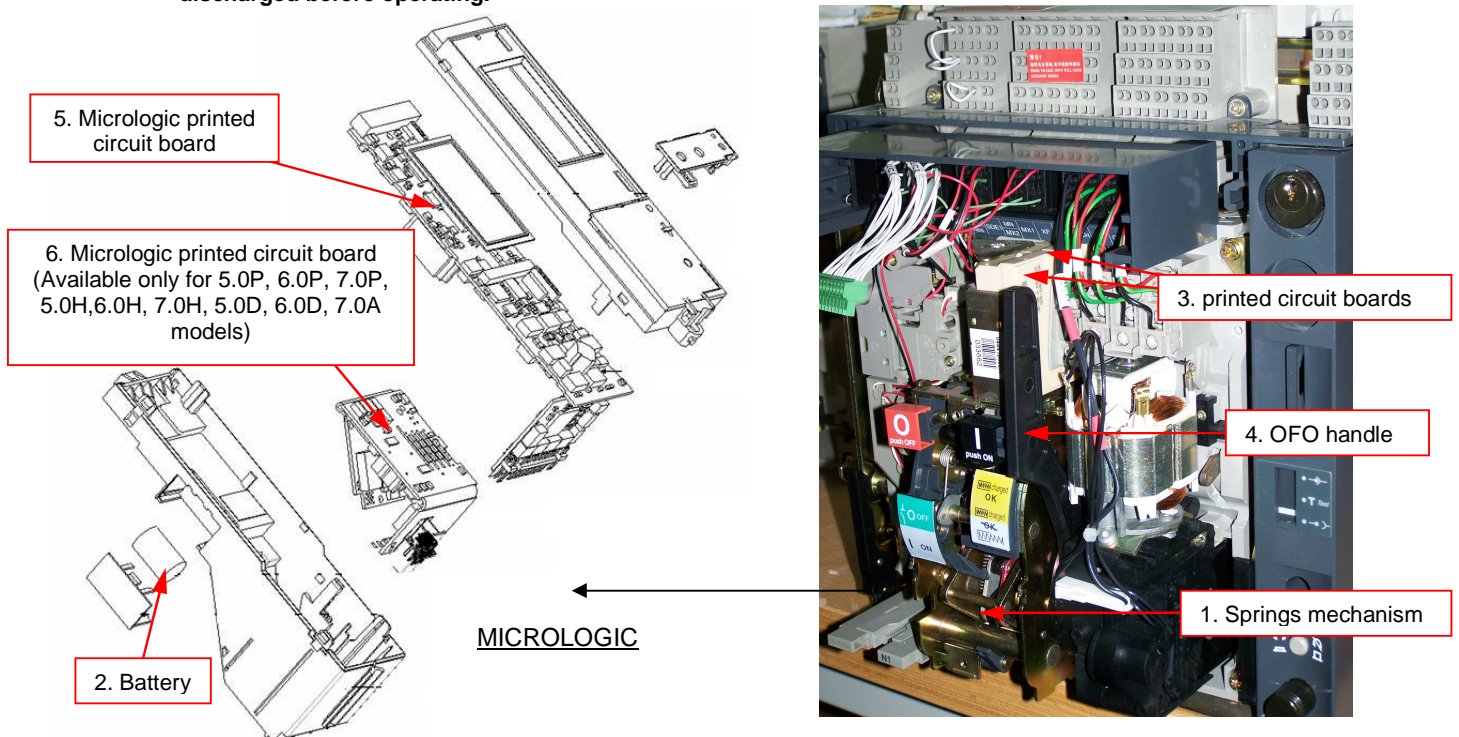
## Operations recommended for the end of life treatment

There are several steps to process the products at the end of life so as to recover components, materials or energy : Reuse → Depollution → Dismantling → Shredding.

The components of the products that optimize the recycling performances are listed, identified and located hereunder.

This product contains printed circuit boards, batteries and a part made of bromide materials which is recommended to be treated separately during the End of Life operations.

Masterpact NT series contain batteries which may cause the electrical shock during the end of life treatment process, even when the equipment is not connected to electrical network. This series also contain a mechanism made of springs which can be charged of energy. Be sure that the product is discharged before operating.
