
General information

Description of the product	The main purpose of the product is to switch on and off electrical power supply of a downstream installation with an electrical and/or mechanical control.
Functional unit	Switch on and off during 20 years electrical power supply of a downstream installation with an electrical and/or mechanical control. The functional unit is characterized by a type 1NO+1NC, a control circuit voltage 230V, a power circuit voltage 690V and a rated operational current 65A.


