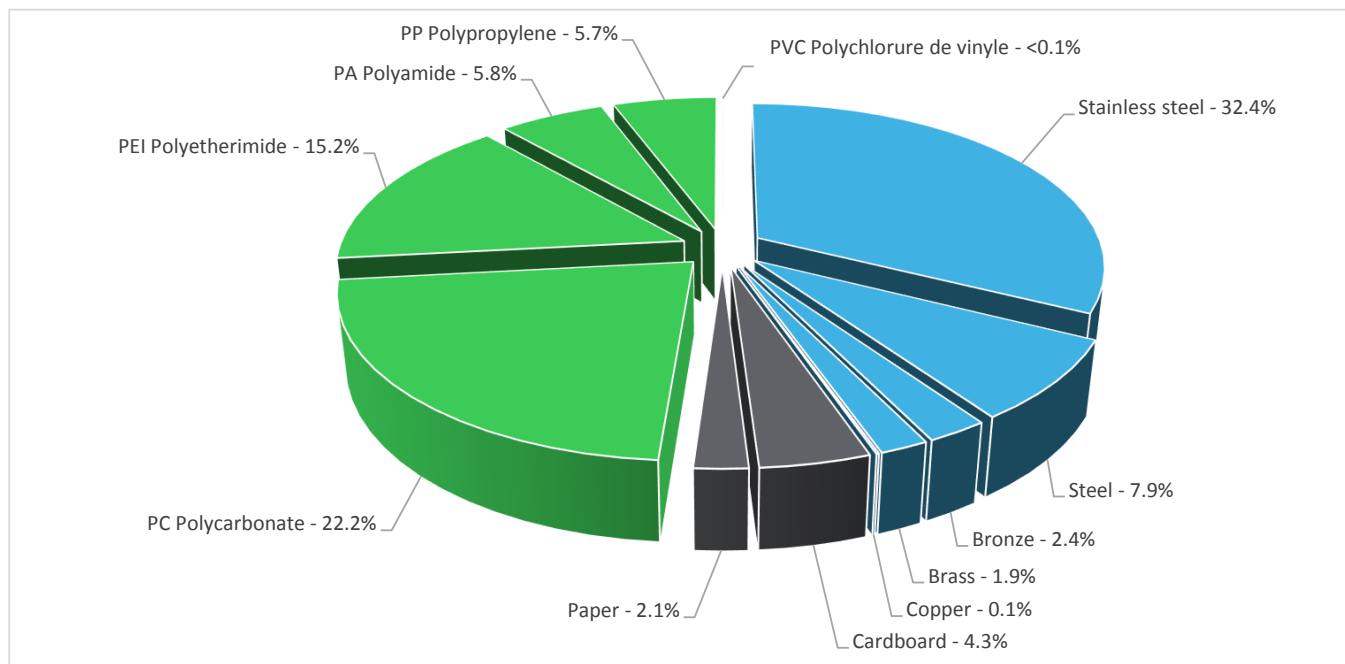
## General information

Description of the product	The main purpose of the Lisse socket switch outlet, rated at 10A 250V AC product range is to give a solution for the control of Electricity.
Functional unit	Connect/Disconnect during 20 years the plug of a load consuming 10A under a voltage of 250V while protecting the user from direct contact with live parts and with a protection class IP20.

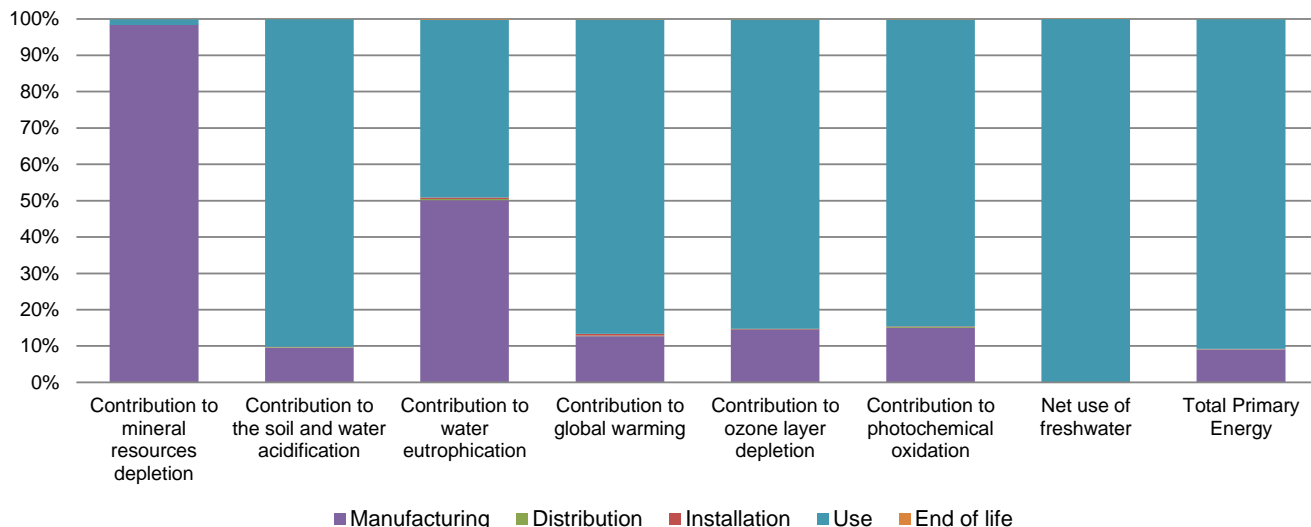
