

# Schneider Electric Security Notification

## C-Bus Toolkit

13 July 2021

### Overview

Schneider Electric is aware of a vulnerability in its C-Bus Toolkit product.

The [C-Bus Toolkit](#) product is an application you run on your personal computer to configure and commission C-Bus Installations.

Failure to apply the remediations provided below may risk a remote code execution attack, which could result in an attacker having remote access to the computer.

### Affected Product and Versions

C-Bus Toolkit v1.15.8 and prior

### Vulnerability Details

CVE ID: **CVE-2021-22784**

CVSS v3.1 Base Score 6.5 | Medium | CVSS:3.1/ AV:N/AC:L/PR:N/UI:R/S:U/C:N/I:H/A:N

A *CWE-306: Missing Authentication for Critical Function* vulnerability exists that could allow an attacker to use a crafted webpage to obtain remote access to the system.

### Remediation

Version 1.15.9 of the C-Bus Toolkit product includes a fix for this vulnerability and is available for download here:

Note: A reboot will be needed after the update.

Customers should use appropriate patching methodologies when applying these patches to their systems. We strongly recommend the use of back-ups and evaluating the impact of these patches in a Test and Development environment or on an offline infrastructure. Contact Schneider Electric's [Customer Care Center](#) if you need assistance removing a patch.

If customers choose not to apply the remediation provided above, they should immediately apply the following mitigations to reduce the risk of exploit:

- Use an allow list for this application
- Turn on the computer's firewall

- Use an antivirus program
- Secure the computer to prevent unauthorized personnel from accessing the computer

### General Security Recommendations

We strongly recommend the following industry cybersecurity best practices.

- Locate control and safety system networks and remote devices behind firewalls and isolate them from the business network.
- Install physical controls so no unauthorized personnel can access your industrial control and safety systems, components, peripheral equipment, and networks.
- Place all controllers in locked cabinets and never leave them in the “Program” mode.
- Never connect programming software to any network other than the network for the devices that it is intended for.
- Scan all methods of mobile data exchange with the isolated network such as CDs, USB drives, etc. before use in the terminals or any node connected to these networks.
- Never allow mobile devices that have connected to any other network besides the intended network to connect to the safety or control networks without proper sanitation.
- Minimize network exposure for all control system devices and systems and ensure that they are not accessible from the Internet.
- When remote access is required, use secure methods, such as Virtual Private Networks (VPNs). Recognize that VPNs may have vulnerabilities and should be updated to the most current version available. Also, understand that VPNs are only as secure as the connected devices.
