Certificate type and validation procedures

Certificates issued within the Schneider Electric Public Key Infrastructure ("Schneider Electric PKI") conform to the RFC 3647, the X.509 v.3 standard ("Schneider Electric Certificates").

Validation procedures are set forth in the Schneider Electric contractual agreements signed with its business partners and clients (the "Relying Parties" or "the Client").

Due to the specific usage of the Schneider Electric Public Key Infrastructure, limited only to the digital signature of products software and/or firmware, there are no others applicable Certificate Authorities ("CA") Policies.

Usage and reliance limits

Subject to the disclaimer and limitation of liability set forth below, Schneider Electric Certificates may be used only for electronic signature authentication and integrity purposes between entities within the Schneider Electric Group (the "Entities") and its business partners and clients. Schneider Electric will deliver Certificates only to the Entities. Specifically these Certificates are used to validate the authenticity and integrity of the Entities software such as products firmware.

Any reliance upon Schneider Electric Certificates is limited to the Relying Parties, who are contractually bound to comply with Schneider Electric Issuing CA rules. These rules ("The Rules") are set forth in agreements governing the relation between these Relying Parties and the Entities.
