



Normal operation, 0 to 50 °C (32 to 122 °F):





### Configuring a Unique MS/TP Address

Configure a unique MS/TP address for the device during installation. Use position 1 to 7 on the Address DIP switch. Position 1 to 7 represent the binary values 1, 2, 4, 8, 16, 32, and 64. For example, to configure MS/TP address 6, set DIP switches 2 and 3 to ON and switches 1, 4, 5, 6, and 7 to OFF. For more information, see the SpaceLogic and EasyLogic - Hardware Reference Guide.
