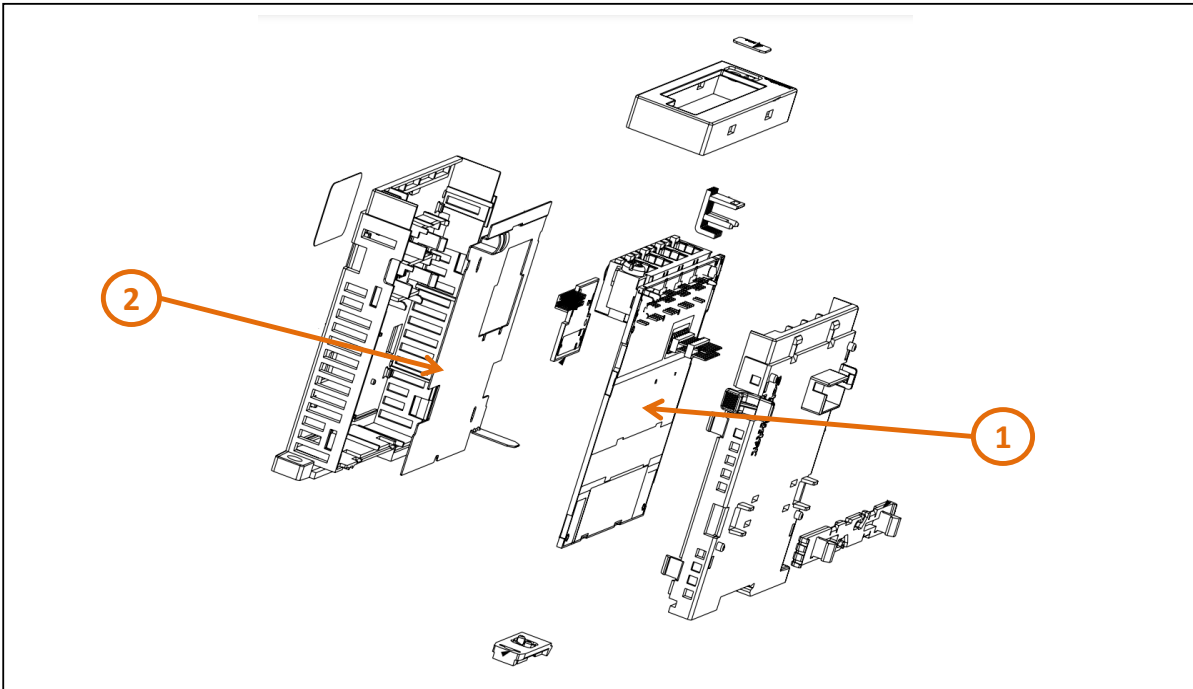
 **Potential disassembly risks**
