


## General information

Reference product	Acti9 ViGi iPN 25A 30mA A ELE - A9Y57625
Description of the product	The main function of this product is to assemble with iDPN MCB and provides protection of persons against electric shock by direct contact and indirect contact, protection of persons against fire ignition by leakage currents, and protection of loads against supply voltage increase (OV offer)
Description of the range	This range consists of RCCB of 25A and 40A, 1 P+N. The representative product used for the analysis is Acti9 ViGi iPN 25A 30mA A ELE (commercial reference: A9Y57625). All the products in this range have the same mass, which is 80g including packing.  The environmental impacts of this reference product are representative of the impacts of the other products of the range which are developed with a similar technology.
