The main purpose of the C-Bus Dimmer is to control the dimmable loads for different scenario.

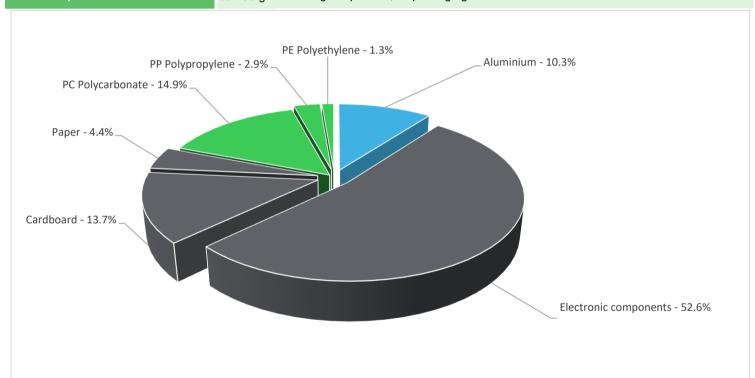
Functional unit

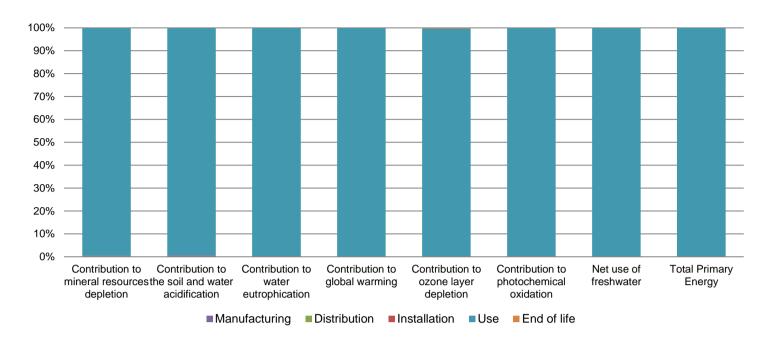
