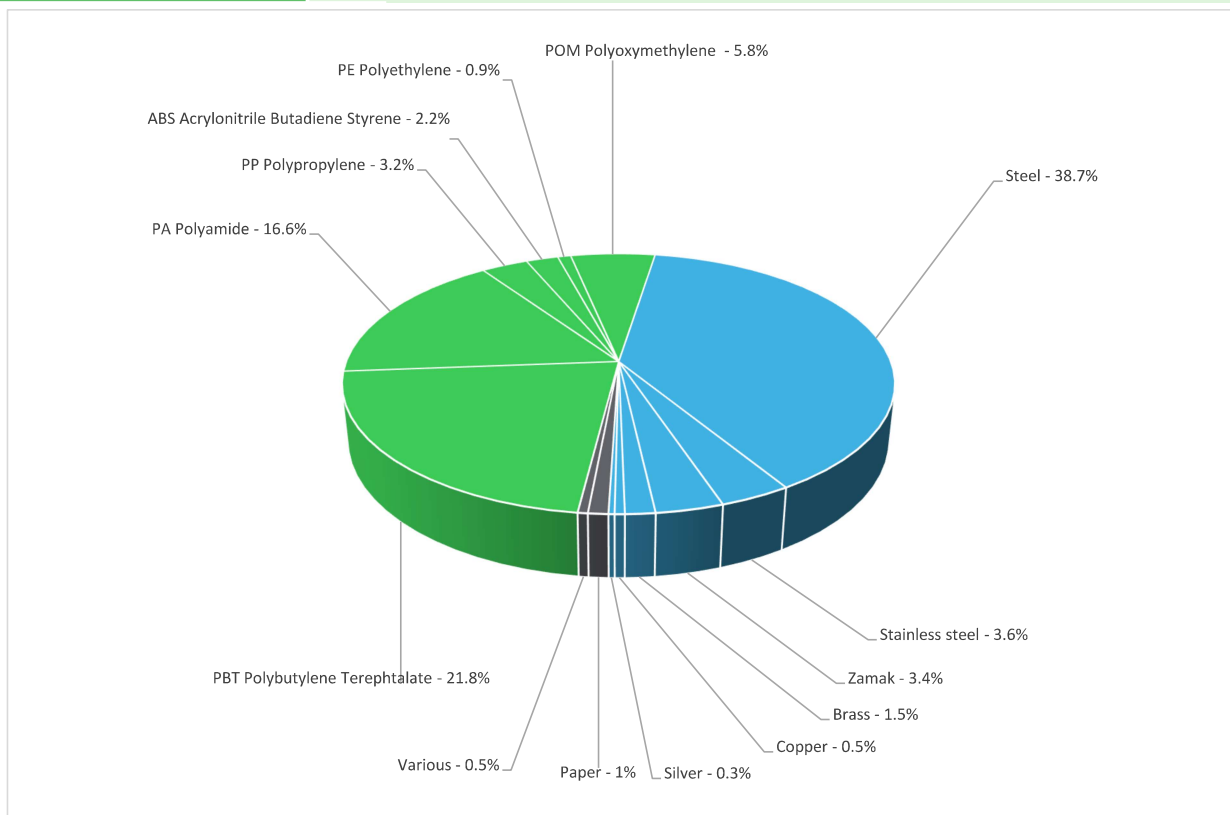


General information

Description of the product	Selector switch can be rotated right, left or in the center in order to open or close the electrical contacts.
Functional unit	Key selector switch comes with key pull out position in left position. It has 2 operating positions and operates with a stay-put mechanism. This selector switch provides a versatile interface for controlling machines. It has 1 NO contact with slow-break operation. This is a plastic switch with a metallic-look ring design bezel. It has power consumption of 0.002W with use rate of 72% for a period of 10 years and product is adhering to standards IEC 60947-1, GB 14048.5 and IEC 60947-5-1 standards.
