This high level analog input module is part of the Modicon X80 modules. It has 8 isolated analog inputs (15 bits + sign) and connected via 28-way removable terminal block. Detect the analog input signal and convert it to the digital signal to be processed by PLC processor.

Functional unit

The Modicon M X80 range has a long life cycle for about more than 10 years with a 100% use rate. Typical electrical power is 1.79W (150 mA 3.3 V DC). The module offers the following ranges of voltage and current : Voltage range: +/-5 V/+/-10 V/0..5 V/0..10 V/1..5 V,

Current range: +/-20 mA/0..20 mA/4..20 mA

IP Degree of Protection: IP20


