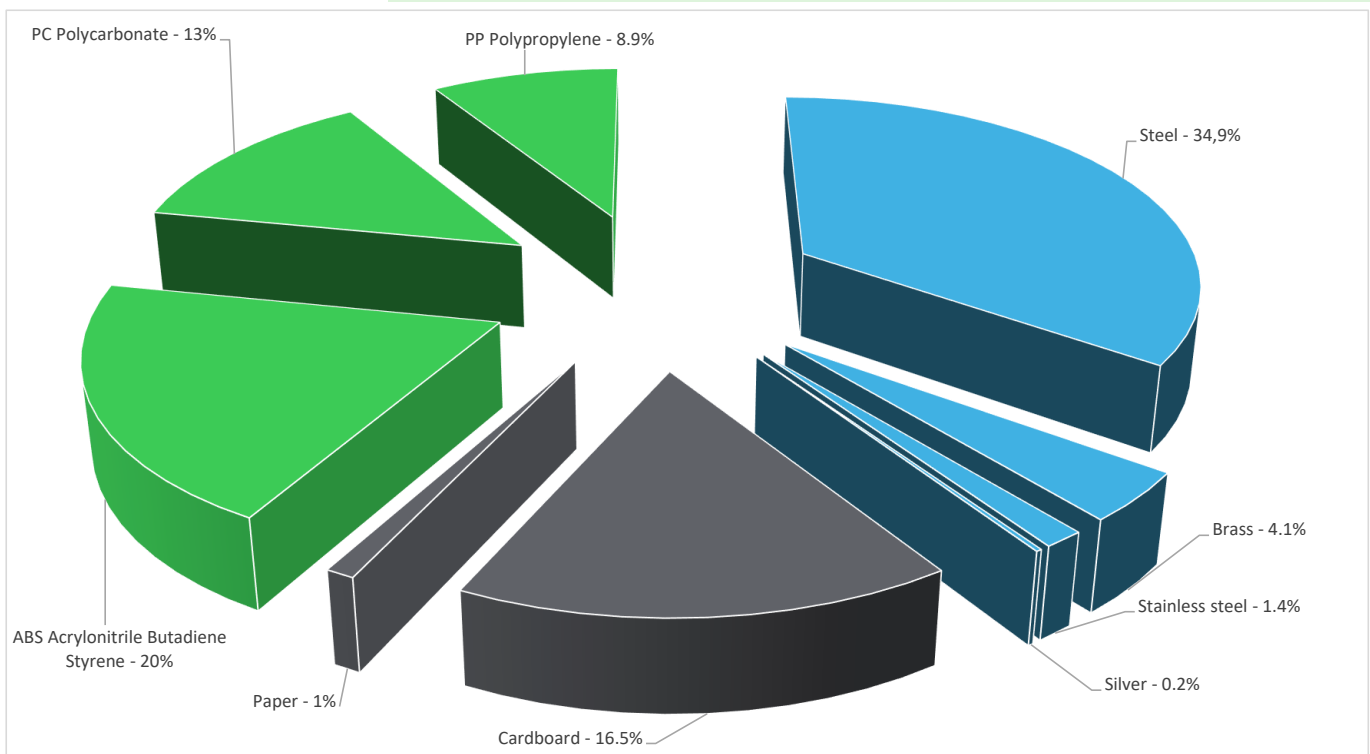
## General information
