## China RoHS Project

Dear customer,

As per the obligations defined in the "Administrative Measures for the Restriction of Hazardous Substances in Electric Appliances and Electronic Products" called China RoHS and released January 21st 2016, amended June 29th 2024 which requires to declare the presence of use of of lead, mercury, cadmium, hexavalent chromium, polybrominated biphenyls (PBB), polybrominated diphenyl ethers (PBDE) flame retardant and 4 phthalates (DEHP, DBP, BBP, DIBP), you will find attached below our best information, as of the date of publication of this information, regarding the presence of Hazardous Substances Schneider Electric products.

For products outside the legal scope, a declaration, only for information, could be provided.

This information will evolve over time, in function of the improved knowledge resulting from both additional information provided by our suppliers and our own investigations.

Since several years, China RoHS and RoHS Europe are Schneider Electric priorities as far as the removing of hazardous substances from its products is concerned.

In the following HST, only the 6 historical substance groups (lead, mercury, cadmium, hexavalent chromium PBB, PBDE) are mentioned as a short tempory situation due to the transition to our new compliance tool. Nevertheless, we can guaranty thanks to our EU RoHS analysis and declaration that this product doesn't contain one of the 4 regulated phthalates. A new declaration with a complete HST will be provided in January 2026 to replace this current declaration.

In accordance with the Environment policy of our Company, we continuously work towards products and services which reduce the impact on the environment or an human health when used for their intended purpose and in conditions stated in the documentation provided by Schneider Electric.

At end of life, we invite you to follow appropriate waste and recycling procedures.
