## **Eurotherm by Schneider Electric GUIcon V2.0**

#### 4 December 2018

### Overview

Schneider Electric has become aware of multiple vulnerabilities in the Eurotherm by Schneider Electric GUIcon product.

### Affected Product(s)

Eurotherm by Schneider Electric GUIcon Version 2.0 (Gold Build 683.0)

### Vulnerability Details

CVE ID: CVE-2018-7813

7.8 | (High) | CVSS:3.0/AV:L/AC:L/PR:N/UI:R/S:U/C:H/I:H/A:H

A Type Confusion (CWE-843) vulnerability exists on pcwin.dll which could cause remote code to be executed when parsing a GD1 file

CVE ID: CVE-2018-7814

7.8 | (High) | CVSS:3.0/AV:L/AC:L/PR:N/UI:R/S:U/C:H/I:H/A:H

A Stack-based Buffer Overflow (CWE-121) vulnerability exists which could cause remote code to be executed when parsing a GD1 file

7.8 | (High) | CVSS:3.0/AV:L/AC:L/PR:N/UI:R/S:U/C:H/I:H/A:H

A Type Confusion (CWE-843) vulnerability exists on c3core.dll which could cause remote code to be executed when parsing a GD1 file

## General Security Recommendations

We strongly recommend following industry cybersecurity best practices such as:

- Locate control and safety system networks and remote devices behind firewalls, and isolate them from the business network.
- Physical controls should be in place so that no unauthorized person would have access to the ICS and safety controllers, peripheral equipment or the ICS and safety networks.
- All controllers should reside in locked cabinets and never be left in the "Program" mode.
- All programming software should be kept in locked cabinets and should never be connected to any network other than the network for the devices that it is intended.
- All methods of mobile data exchange with the isolated network such as CDs, USB drives, etc. should be scanned before use in the terminals or any node connected to these networks.
- Laptops that have connected to any other network besides the intended network should never be allowed to connect to the safety or control networks without proper sanitation.
- Minimize network exposure for all control system devices and/or systems, and ensure that they are not accessible from the Internet.
- When remote access is required, use secure methods, such as Virtual Private Networks (VPNs), recognizing that VPNs may have vulnerabilities and should be updated to the most current version available. Also recognize that VPN is only as secure as the connected devices
