Security Notification – Vijeo Designer Lite

14 February 2019

Overview

Schneider Electric has become aware of a vulnerability in the Vijeo Designer Lite product. It is used to configure the following products:

- XBTN200
- XBTN400
- XBTN401
- XBTN410
- XBTNU400
- XBTR400
- XBTR410
- XBTR411
- XBTRT500
- XBTRT511

Affected Product(s)

- Vijeo Designer Lite V1.3SP1

Vulnerability Details

7.8 | (High) | CVSS:3.0/AV:L/AC:L/PR:N/UI:R/S:U/C:H/I:H/A:H

A Buffer Error (CWE-119) vulnerability exists which could cause a crash of Vijeo Designer Lite software when opening a DOP project file.

Remediation

Vijeo Designer Lite was announced end of service in June 2017.

For customers requiring this software, the following safeguards are advised:

- Install and operate Vijeo Designer Lite on a dedicated system with minimum necessary privileges and access (particularly system and user account access to other devices and network services), and ensure the dedicated system is kept up-to-date with the latest operating system patches
- Only open DOP project files from trusted sources

General Security Recommendations

We strongly recommend following industry cybersecurity best practices such as:

- Locate control and safety system networks and remote devices behind firewalls, and isolate them from the business network.
- Physical controls should be in place so that no unauthorized person would have access to the ICS and safety controllers, peripheral equipment or the ICS and safety networks.
- All controllers should reside in locked cabinets and never be left in the “Program” mode.
- All programming software should be kept in locked cabinets and should never be connected to any network other than the network for the devices that it is intended.
- All methods of mobile data exchange with the isolated network such as CDs, USB drives, etc. should be scanned before use in the terminals or any node connected to these networks.
- Laptops that have connected to any other network besides the intended network should never be allowed to connect to the safety or control networks without proper sanitation.
- Minimize network exposure for all control system devices and/or systems, and ensure that they are not accessible from the Internet.
- When remote access is required, use secure methods, such as Virtual Private Networks (VPNs), recognizing that VPNs may have vulnerabilities and should be updated to the most current version available. Also recognize that VPN is only as secure as the connected devices.
