Galaxy VS and Galaxy VL

14 November 2023 (9 April 2024)

Overview

Schneider Electric is aware of a vulnerability in its Galaxy VL and Galaxy VS products.

The Schneider Electric [Galaxy VS](#) products are 3-phase UPS for edge, small, and medium data centers and other business-critical applications. The Schneider Electric [Galaxy VL](#) products are 3-phase UPS featuring modular, redundant design and low TCO for medium and large data centers and mission critical environments.

Failure to apply the remediations or mitigation provided below may risk path traversal, which could result in file system enumeration and file download.

April 2024 Update: A remediation is available for the Galaxy VS.

Vulnerability Details

CVE ID: **CVE-2023-6032**

CVSS v3.1 Base Score 5.3 | Medium | CVSS:3.1/AV:N/AC:L/PR:N/UI:N/S:U/C:L/I:N/A:N

CWE-22: Improper Limitation of a Pathname to a Restricted Directory ('Path Traversal') vulnerability exists that could cause a file system enumeration and file download when an attacker navigates to the Network Management Card via HTTPS.

Note regarding vulnerability details: The severity of vulnerabilities was calculated using the CVSS Base metrics in version 3.1 ([CVSS v3.1](#)) without incorporating the Temporal and Environmental metrics. Schneider Electric recommends that customers score the CVSS Environmental metrics, which are specific to end-user organizations, and consider factors such as the presence of mitigations in that environment. Environmental metrics may refine the relative severity posed by the vulnerabilities described in this document within a customer's environment.

General Security Recommendations

We strongly recommend the following industry cybersecurity best practices.

- Locate control and safety system networks and remote devices behind firewalls and isolate them from the business network.
- Install physical controls so no unauthorized personnel can access your industrial control and safety systems, components, peripheral equipment, and networks.
- Place all controllers in locked cabinets and never leave them in the “Program” mode.
- Never connect programming software to any network other than the network intended for that device.
- Scan all methods of mobile data exchange with the isolated network such as CDs, USB drives, etc. before use in the terminals or any node connected to these networks.
- Never allow mobile devices that have connected to any other network besides the intended network to connect to the safety or control networks without proper sanitation.
- Minimize network exposure for all control system devices and systems and ensure that they are not accessible from the Internet.
- When remote access is required, use secure methods, such as Virtual Private Networks (VPNs). Recognize that VPNs may have vulnerabilities and should be updated to the most current version available. Also, understand that VPNs are only as secure as the connected devices.
