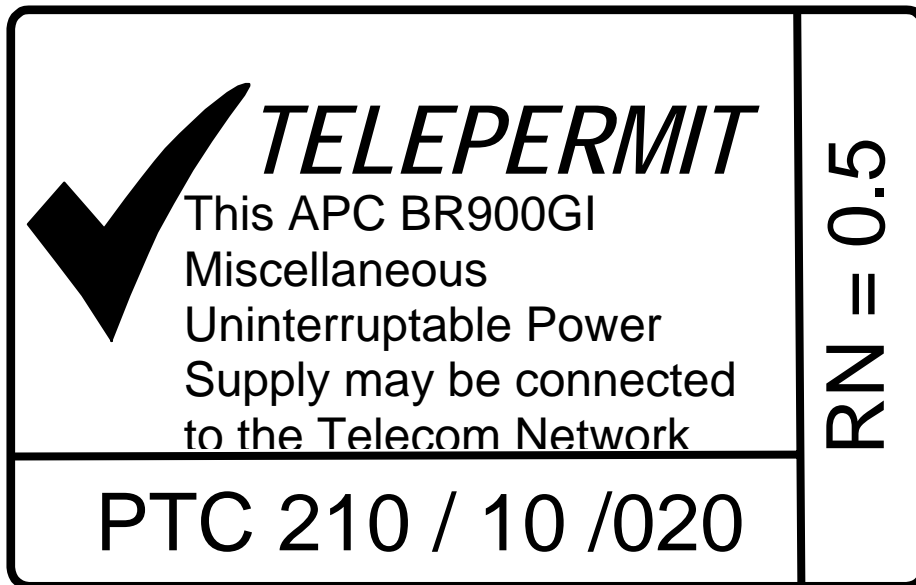
1. As required by PTC 100, please ensure that this office is advised of any changes to the specifications of these products that might affect compliance with the relevant PTC Specifications.
