


## General information

Description of the product	The main purpose of the ComPacT NS1000N 3P circuit breaker equipped with a MicroLogic 5.0 A Control Unit is to protect and control low-voltage distribution systems. The data used to make this PEP are the most representative of the product studied. No missing data is to be declared.
Functional unit	Protect during 20 years the installation against overloads and short-circuits in circuit with assigned voltage up to 690V and rated current up to 1600A. This protection is ensured in accordance with the following parameters:  - Number of poles = 3P  - Rated breaking capacity = N 50kA 415V AC  - Tripping curve = Adjustable [LSI = long time, short time, instantaneous]  - IP degree of protection = IP40 conforming to IEC 60529  - IK degree of protection = IK07 conforming to EN 50102
